

# Release of State Government subsidy for establishing Neera Processing Unit

Government of Kerala has released Rs.50 lakhs to M/s. Kaipuzha Coconut Producer Company Ltd., Kollam for establishing Neera Processing Unit. Shri. T. K. Jose IAS, Chairman, Coconut Development Board handed over the Demand Draft of Rs.50 lakhs to Shri. Shajahan Kanjiravilayil, Chairman, Kaipuzha Coconut Producer Company Ltd., Kollam and Chairman, Consortium of Coconut Producer Companies, Kerala at H.Q., Coconut Development Board on 19<sup>th</sup> October 2015.

The Government of Kerala has provided the assistance through Coconut Development Board as per the order no. TM (2) 41746/2015 dated 15.10.2015 by Director of Agriculture, Govt. of Kerala. Earlier Government of Kerala had announced financial assistance to the Coconut Producer Companies who are venturing in to establishment of Neera Processing unit vide GO (MS) NO.111/2015 dated 22.06.2015.

Coconut Development Board had already approved the project of Kaipuzha Coconut Producer Company Ltd. for assistance under Technology Mission on Coconut (TMOc). At present, along with M/s. Kaipuzha Coconut Producer Company Ltd, other Coconut Producer Companies Viz. M/s. Karappuram Coconut Producer Company Ltd., Alappuzha, M/s. Kuttiady Coconut Producer Company Ltd., Kozhikode, M/s. ### ORDER

As per the letter read above, the Chairman, Coconut Development Board submitted the Proposal for allocation of funds to Kaipuzha Coconut Producer Company Limited for Neera production in accordance with the Order read as 1 above. Coconut Development Board has requested Government to sanction 25% of the capital cost of Kaipuzha Coconut Producer Company Limited subject to a maximum of ₹ 1.0 Crore.

Government have examined the proposal of Coconut Development Board and are pleased to accord administrative sanction for the allocation of funds for Neera production for an amount of ₹ 50.00 lakh (Rupees Fifty lakh only) by debiting the expenditure from the head of account 2401-00-108-30(P) - Keramrutham(Neera) and Kerachakkara. The Director of Agriculture will draw and disburse the amount to concerned.
