Minutes of Review Meeting held on 06.12.2018 at CDB, HO, on action taken for decisions of 134th Board Meeting

A Review Meeting was held under the Chairmanship of Shri Saradindu Das, CCDO, CDB in the CCDO's Chamber at 4.30.pm with the Officers of the Board in order to discuss about the action taken for decisions of 134th Board Meeting held on 25th October 2018 at Bhubaneswar. The following Officers attended the meeting.

- 1. Shri. Saradindu Das, Chief Coconut Development Officer- In Chair
- 2. Shri. Rajat Kumar Pal, Deputy Director (Development)
- 3. Smt. Deepthi Nair S, Deputy Director (Marketing)
- 4. Smt. Leenamol M A, Market Promotion Officer

Based on the discussion, following decisions were made.

- 1. Regarding payment of skilled labour wages to labourers engaged in DSP Farm. Pitapally, recommendations of the Expert Committee visited all 11 DSP Farms of the Board and necessary action for encroachment and construction of compound wall at DSP Farm, Madhepura as per Expert Committe report, which are included in the 5th,6th and 7th points respectively under Subject No.2 of the Minutes of 134th Board Meeting, necessary follow up action should be taken by the Deputy Director (Farms) and file should be submitted before the competent authority.
- 2. Regarding point No.8 under Subject No.2 of the Minutes, letter to be sent from CCDO to Director (Agriculture) for extension of lease DSPF, Neriamangalam.
- 3. Regarding point No.11 under Subject No.2 regarding Coconut Palm Insurance Scheme (CPIS), action already taken.
- 4. CCDO informed that regarding the 10th point under Subject No.2 of Minutes of 134th Board Meeting, indicating issueing of copy of the press release issued by the Horticulture Commissioner, Govt. of India against false propaganda on coconut oil in
- Oriya language, by CDB, Odisha office to all local dailies, action has already taken up.
- 5. CCDO informed that regarding 12th point under Subject No.2 of the Minutes of 134th Board Meeting, indicating the issue of getting land at Vijayawada for the office of the CDB, requesting Secretary (Agriculture). Govt. of India to write a letter to the Chief Secretary, Govt. of Andhra Pradesh, follow up action has already initiated by the Board.

 indicating submission of ideas for revitalizing Schemes presently being implemented
 by CDB, follow up action should be taken by Deputy Director (Planning).

- 8. Regarding the 22nd point under Subject No.9 of the Minutes, indicating assistance for quality certification of coconut processing units, application has already uploaded in the website and may be by the end of December it should be processed and submitted before the competent authority.
